

## Newsletter Regulations

effective from 01.06.2019

The Regulations specify the rules of using the Newsletter service.

The Newsletter service is provided by Cafardini Spółka z ograniczoną odpowiedzialnością with its registered office in Łańcut, ul. Podzwierzyniec 29, 37-100 Łańcut, entered into the Register of Businesses of the National Court Register by the District Court in Rzeszów, XII Commercial Department of the National Court Register, under the number KRS 0000236724, with the share capital of PLN 50,000.00, Taxpayer Identification Number (NIP): 8151679324, National Business Registry Number (Regon): 180046703, hereinafter referred to as "Cafardini".

As part of the Newsletter service, Cafardini sends information in the form of an electronic letter (e-mail), hereinafter referred to as the "Newsletter", to the electronic mail address (e-mail address) provided by the User.

The Newsletter service is provided free of charge for an indefinite period of time.

The Newsletter contains information about Cafardini's offer, new collections, current promotions, other information about Cafardini and its products, including opinions, press releases, links to websites befriended with Cafardnini

Each Newsletter comprises:

- 1) information about Cafardini sp. z o.o. with its registered office in Łańcut as the Newsletter sender,
- 2) a filled in "Subject" field specifying the content of the Newsletter,
- 3) information on how to resign from the Newsletter service or change the electronic mail address (e-mail address) of the User to whom the Newsletter is sent.

The use of the Newsletter service depends on the User's possession of a computer or other multimedia device with access to the Internet and on the User's possession of an active electronic mail account (e-mail).

The Newsletter service is ordered by the User by performing the following registration activities on the website [www.cafardini.com](http://www.cafardini.com)

- 1) providing the User's electronic mail address (e-mail address) in the form available on the website,
- 2) consent to receive commercial information to the electronic mail address (e-mail address) given in the form
- 3) acceptance of these Regulations,
- 4) pressing (clicking) the "Save" button,
- 5) clicking on the link confirming registration contained in the e-mail sent by Cafardini

By pressing (clicking) on the link confirming the registration, the User's electronic mail address (e-mail address) is added to the e-mailing list. The User's electronic mail address (e-mail address) will be used to send the Newsletter to the User.

Providing the User's electronic mail address (e-mail address) in the form during the registration process is necessary for the provision of the Newsletter service.

The Controller of the Users' personal data is Cafardini sp. z o.o. You can contact us by writing to us at the address: ul. Podzwierzyniec 29, 37-100 Łańcut.

We process the User's personal data in connection with participation in the Newsletter service.

Providing personal data and consent to participate in the Newsletter service is voluntary.

The legal basis for processing the User's personal data is the consent given (Article 6 paragraph 1 (a) of the GDPR)

Personal data will be stored until the User withdraws his or her consent.

We will pass on your personal data to companies that support us in the area of marketing services.

You have the right to demand that we have access to your data and that you receive a copy of it, rectify (correct) it, transfer it and delete it, as well as the right to restrict the processing of your data.

In connection with the processing of personal data by us, the User has the right to object to the processed data, the right to lodge a complaint with the President of the Office for Personal Data Protection and the right to withdraw the consent to the processing of personal data.

We will not make automated decisions, including those resulting from profiling, with respect to the Users based on personal data.

The User may at any time, without giving any reason and without incurring any costs, change the previously indicated electronic mail address (e-mail address) to which the Newsletter is sent or resign from the Newsletter service by writing an e-mail to [rezygnacja@cafardini.com](mailto:rezygnacja@cafardini.com)

As part of the Newsletter service, the User is prohibited from providing or transmitting illegal content.

Complaints concerning the Newsletter service can be submitted:

- 1) by electronic mail to the electronic address [rezygnacja@cafardini.com](mailto:rezygnacja@cafardini.com)
- 2) by snail mail

Cafardini reserves the right to amend the Regulations. We will inform the Users about the content of amendments to the Regulations by placing on the website [www.cafardini.com](http://www.cafardini.com) a message about the amendments to the Regulations, containing a list of amendments to the Regulations and maintaining this information on the website [www.cafardini.com](http://www.cafardini.com) for at least 14 consecutive calendar days. The User will be additionally informed about an amendment to the Regulations by sending through the Newsletter and to the electronic mail address (e-mail address), provided during registration, containing a list of the amendments to the Regulations. The notification of the amended Regulations will be made no later than 14 calendar days before the introduction of the amended Regulations.

Amendments to the Regulations enter into force on the date given together with the information about their amendment, but not earlier than 14 calendar days after the notification of amendments to the Regulations, with the reservation that the amended Regulations will be binding on the User, unless within 14 days from the date of receipt of the information about their amendment the User declares that he/she resigns from the Newsletter service if they do not accept the new content of the Regulations.
